2026 Art/Craft Vendor Booth Application Basic Information

What do I need to know before I apply for a booth?

- Festival hours are Saturday, November 14th 10:00am-4:00pm & Sunday, November 15th 10:00am-3:00pm.
- Exhibitors must exhibit their own original work.
- There will be limited vendors in each category.
- The following items are prohibited and will not be accepted: Manufactured articles, dealer's imports, velvet paintings, loose stones, commercial patterns, and items purchased for resale. Jewelry not designed and assembled by the exhibitor is prohibited.
- NO alcohol, drugs or unlawful transactions are permitted. If any violation occurs, the entry is forfeited and the exhibitor will be asked to leave.
- Great Day in the Country is held rain or shine. There is no rain date. If weather conditions are extremely unfavorable, the GFWC Oviedo Woman's Club may cancel all activities.

What are the requirements for registration?

- Registration and payment are required prior to the event. We accept applications online or by mail.
- Online registration will accept credit card payments.

- Once you have applied and your application has been accepted, you will receive a confirmation email within 90 days.
