TERMS OF AGREEMENT

This agreement shall become effective once payment is received and the agreement is signed by both parties.

This agreement shall remain in effect until the event ends on November 15th, 2026, or until responsibilities are fulfilled.

This agreement defines the terms under which the GFWC Oviedo Woman's Club and (sponsor) _____ enter into a sponsorship agreement for the 52nd Annual Great Day in the Country Arts & Crafts Festival beginning November 14th, 2026.

Limited license: GFWC Oviedo Woman's Club grants the sponsor limited license to use any of the artwork on the event site for the purpose of promoting the event and linking to the event site. Sponsor grants GFWC Oviedo Woman's Club a limited license to use the sponsor's logo in festival promotional material and on the event site.

The parties acknowledge they will use good faith efforts to negotiate and resolve any unforeseen occurrences, and that they may alter the conditions of this agreement.

Cancellation policy: This agreement is effective as of the date signed below and shall remain effective until the event ends on November 15th, 2026, or is terminated by festival management. Sponsorship may include promotional items, and once the contract is signed and payment received, there shall be no refunds. GFWC Oviedo Woman's Club may terminate this agreement at any time by notifying the sponsor in writing or email.
